ALICE is an acronym for **Asset Limited, Income Constrained, Employed**, and represents the growing number of families who are unable to afford the basics of housing, child care, food, transportation, health care, and technology. These workers often struggle to keep their own households from financial ruin, while keeping our local communities running.

CRISIS INTERVENTION

In FY2024- 2025, United Way of Southern Chester County **invested \$329,480 across 16 programs that provide critical support** to struggling families in our community. With a growing number of ALICE households and ongoing cuts to government funding, these **programs increasingly rely on United Way support** to keep families from slipping into poverty. We fund agencies with proven track records of helping families move from crisis to independence, ensuring every person has the opportunity to get on a path toward financial security. Our investments **address urgent needs**—such as housing, food, and emergency assistance—while building long-term stability. In addition, our **partnership with the 211 crisis hotline**, run by Chester County Human Needs Network and United Way of Pennsylvania, offers immediate support and ensures no one is alone in their time of need.

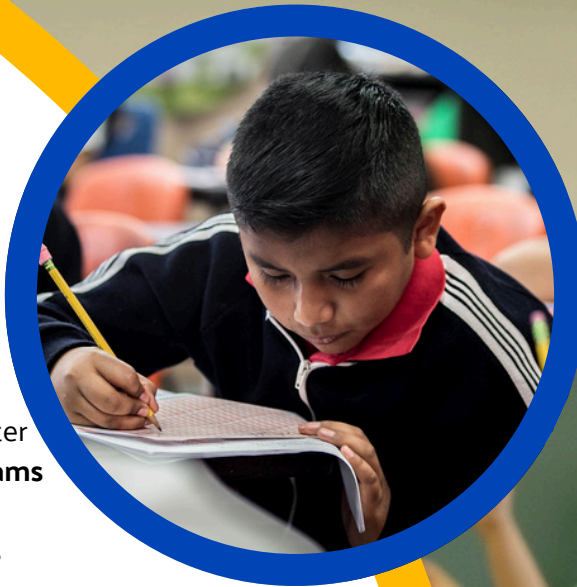

EDUCATION IMPACT

In FY 2024-2025, United Way of Southern Chester County **invested \$176,280 across seven programs** focused on expanding youth opportunity and supporting lifelong learning. These investments

strengthen parents, caregivers, and communities, while creating opportunities for young people to prepare for college, develop critical skills, and succeed in life. Our funded programs also address adult literacy, helping neighbors gain the tools they need to build stable homes and secure employment. We prioritize high-quality out-of-school programming that keeps students engaged, supported, and set up for success.

In addition, our Back-to-School Drive provided over \$1,400 in in-kind donations, ensuring children had the supplies they needed to start the year ready to learn. Together, we are opening doors to brighter futures through education.

HEALTH & WELLNESS IMPACT

In FY 2024-2025, United Way of Southern Chester County **invested \$144,240 across eight programs** dedicated to supporting the health and wellness of our neighbors. These initiatives **address both physical and mental health**, ensuring community members have access to essential services that promote healing, stability, and long-term wellbeing.

Beyond program funding, we also mobilized the community through **in-kind supply drives** to meet immediate needs. This year, drives for feminine hygiene products and diapers provided critical support for families and were distributed through our nonprofit agency partners, ensuring they reached neighbors who needed them most. Together, **these investments and community efforts reduce barriers to care, strengthen wellness, and create a healthier foundation** for families and individuals across Southern Chester County.

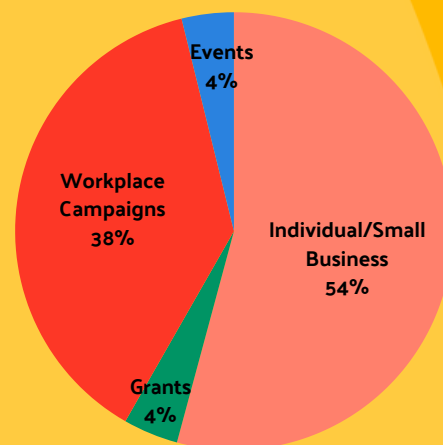

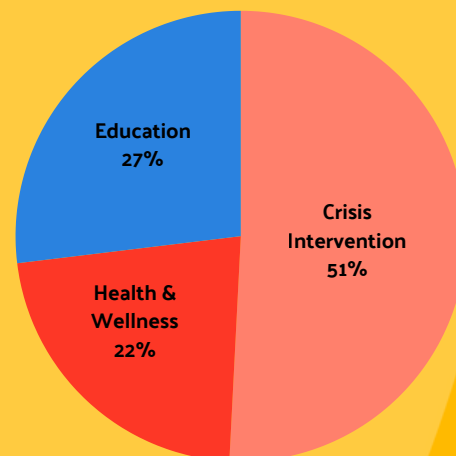

Campaign Revenue Breakout

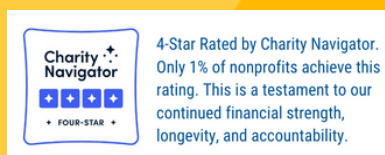


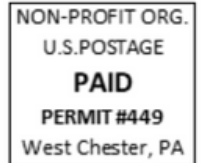
